# **About this Privacy Policy**

Canberra Brass Incorporated ("we", "us" or "our") recognises the importance of privacy and is committed to protecting the privacy of individuals when handling their personal information. We handle personal information for purposes relating to Canberra Brass Incorporated functions and activities.

This Privacy Policy outlines how we handle personal information in an open and transparent manner consistent with the Australian Privacy Principles contained in the Commonwealth *Privacy Act 1988*. If you provide us with any personal information about another individual then we rely upon you to inform him or her of the details contained in this Privacy Policy.

### **Definitions**

**Personal information** means information or an opinion (including information or an opinion forming part of a database) whether true or not, and whether recorded in a material form or not, about an individual whose identity is apparent, or can reasonably be ascertained, from the information or opinion.

### Why we collect, hold, use and disclose personal information

We collect, hold, use and disclose personal information for purposes relating to our organisational functions and activities. We will not collect personal information unless the information is necessary for one or more of its functions or activities, only in legal and fair means, and not unreasonably intrusive. As far as reasonably possible, information about you will be collected from you or your legal guardian.

### What kinds of personal information we collect

The kinds of personal information that we may collect and hold include your name, phone number, email address, address, membership history, purchase history and any other information that you

### How we collect personal information
